Report of the 2006 Committee on Elections

Milwaukee, Wisconsin

TO: NRA Annual Meeting of Members

The Bylaws of the Association designate the NRA Committee on Elections as being responsible for the conduct of the election of Directors. The Committee selected the firm of **Deloitte**, one of the international "Big 5" accounting firms, to assist with the election. The Committee also selected the document-imaging services of Copy General in Sterling, Virginia, to optically scan the ballots.

The detailed procedures to maintain control over the ballots, determine their validity, and assure accurate scanning and tabulation were described to Committee members prior to the beginning of ballot tabulation. The procedures assured compliance with all provisions of the NRA Bylaws; and the Committee met with both **Deloitte** and Copy General to confirm that all requirements were being met.

Deloitte has certified the following results:

A total of 1,547,729 ballots were mailed to eligible voting members of the Association for the election of twenty-five Directors for three-year terms ending in 2009 and one Director for a two-year term ending in 2008. A total of 79,227 ballots (5.1%) were cast by eligible members. All ballots received were valid except for a total of 2,700, or 3.4% of the ballots cast, which were judged invalid for the following reasons:

A total of 1,086 ballots included write-in votes or a combination of write-in votes and votes for candidates on the printed ballot. In no instance did a write-in candidate receive as many votes as any candidate on the printed ballot. No write-in candidate received 250 or more votes.

In accordance with Article VIII, Section 2, of the Bylaws, as Chairman of the Committee on Elections, I declare the following 25 members to have been elected Directors of the NRA for three-year terms ending in 2009, to take office from the adjournment of this meeting:

*(Elected to complete an unexpired term for two-years ending in 2008. Subsequent to the 2005 election process, Kayne Robinson, a Director elected in 2005, resigned his position on the Board of Directors to assume the role of Executive Director, NRA General Operations. As a result of the vacancy, Todd A. Walker was the candidate receiving the next highest total of votes, and was elected to complete the unexpired term of Kayne Robinson.)

Dr. David I. Caplan passed away on April 24, 2006, during the election process. The vote count for Dr. Caplan would have placed him fourth overall with a total of 58,684; however, as a result of Dr. Caplan's death, everyone ranked below him on the list moved up one position.


The remaining candidates on the ballot, who were not elected, are as follows:

One additional Director also will be elected for a one-year term by those members present and voting at this Annual Meeting of Members. This includes not only Lifetime Members and Annual Members with five or more consecutive years of membership who were eligible to vote in the mail elections, but ALL Annual Members present whose fully paid membership was received by the Secretary on or before March 31, 2006, who have attained the age of 18 years and who are citizens of the United States. Candidates for election at this Annual Meeting of Members are those candidates who were nominated previously for the mail election of Directors but failed to be elected.

Voting for this additional Director began Friday at 8:00 am in the Membership Verification Room and will close today at 4:00 p.m., or upon the adjournment of this Annual Meeting of Members, whichever is later. The results will be announced this evening at the Members Banquet, and will also be published in the Official Journal along with this Report.
