And to discuss that, I've got, somebody who was intimately involved in that situation, Chuck Michel, who's the president of the California Rifle and Pistol Association and also was, the lawyer on the challenge to that law. And who has, I think it's fair to say, going up against Kamala. Kamala Harris, a number of times, throughout his, his career, out there in California.

It's not just political, it's also supporting all the recreational and, and, activities that that shooters enjoy participating in. Many of the leading gun rights associations as clients over that time.

And then I'm also the president of the Second Amendment Law Center, which is something that was created by me and a number of other leading Second Amendment attorneys across the country after Bruin came down, because there's so much litigation going on across the country on a variety of different issues, Second Amendment issues that there was a need to coordinate.

And we're pretty much involved in, in all the cases across the country trying to support the people who are fighting for your Second Amendment rights.

And, key to our conversation today, you've been working specifically in California on Second Amendment issues, filing gun rights lawsuits there for, several decades now, including the entire length of Kamala Harris's right.

Right, right. And when we started, we didn't have Heller. We didn't have a recognition by the courts that the Second Amendment protected a fundamental individual. Right. So we always had to rely on due process issues, because often these ordinances or state laws are almost impossible to understand. You know, what is an assault weapon? They don't define that in a way anybody can easily understand.

So people are accidentally violating the law or police or accidentally arresting people for a gun that's not covered by the law. So.

And yeah, and speaking of that time period, the pre Bruen pre Heller time period, that's what we're looking at with this. Our main first topic here right of the show, this or this, city or measure I guess is a ballot measure. It wasn't passed by the Board of Supervisors. It was. It was supported by four of them, which is what you need, by the way, how many do you know?

How many supervisors are on the. I think there's.

No, you didn't have four people just to put it on the ballot. You needed four votes to get it on the ballot. You didn't have the votes to pass it by the city, by the county board of supervisors. They had enough to get it on the ballot, though, so people could vote on it. But this was part of the preemption doctrine, which was the other big argument, legal argument that we used to be able to use to to oppose gun control efforts, either at the local level in particular.

And so Cisco San Francisco tried twice to ban handguns once. Yeah. And Feinstein led the effort.

And we'll get it. We'll get into that for sure. Well, I want to talk about, the whole history here. But first I want to just go over what exactly was at issue. And this was called proposition H. It was 2005. It the the got the four votes signatures necessary for it to be put on, the ballot as a, as a ballot measure, not as, something the board would pass, it seemed to have very little support beyond those four supervisors.

Harris seems to be the only named person who was in city government at the time that that actually backed this alongside those supervisors. But, at least according to the San Jose Mercury News at the time, but but, this measure was a total ban on handgun possession, not just, a ban on future sales or something of that nature.

Ban possession had also banned, all gun sales.

Right. This is I and I think this is especially relevant because this is the most extreme measure that Harris has ever supported as far as we know. And it has this I mean, this is a total ban on, on ownership of handguns by anyone who was a San Francisco resident. They did have exceptions for people who, were active duty police, military or security guards.

But that's it. Everyone else would have had to turn in their guns with. Right? 90 days. Right. Was the deadline set in this proposition, of its enactment? And then there were supposed to set up in consultation with actually the district attorney's office. So, Kamala Harris would have been involved in this, penalties for people who didn't turn in their guns.

Right. But before we get into further underrated, do you know if that process ever occurred? I don't seem to be any information on that. I mean, you guys filed suit before this went into effect, so.

Yeah, we stopped it before it took effect. So the infrastructure to enforce it wouldn't have been set up either by the Da or the San Francisco City Attorney's office. So because we stopped it before there were able to enforce it, but, okay.

But so but first, first things first. Here we have the San Jose Mercury News report that says Kamala Harris supported this bill alongside those four, supervisors. And then you specifically remember her supporting this bill, correct?

You know, she was opposed to pretty much gun ownership in general. She was very active in opposing people getting concealed carry permits. So she's been she she's showed her true colors in California for years, for decades.

Right. But, because this is something her campaign has not commented on. They did not reply to any of the questions that I asked, or apparently to other outlets who also covered this subsequently, including, I think, the New York Post, and The Daily Caller, so that there been a number of people have asked them about this, and she has not responded to any of that.

Maybe she will by the time this podcast goes up, I don't know. But for now, she isn't saying anything one way or the other, but it is clear, I think, that she did act. She did support this. Do you do you recall anything in particular that she did? I guess the only thing, that I'm wondering is like, how did she supported this was 2005, to be fair.

So I think it's pretty clear that she supported it. Maybe she didn't have the biggest role in defending it or getting it passed.

It did pass, by the way, 58% vote, which was, significantly less than apparently the polling had indicated at the time. I think there was initially there was a poll that came out from reporting that I read, that had it at 70 plus percent support, passed by 58. Then you guys filed. So you filed suit.

But this is kind of one of the reasons, I guess, well, sorry, I'm getting ahead of myself a little bit here. It's interesting, one of the interesting things about Harris supporting this is that a lot of prominent gun control activists in California and in San Francisco didn't support this. In fact, it get a lot of opposition, from even, police groups at the time.

The police, one of the biggest police groups in San Francisco, actively opposed the measure, told their members to vote against it, because I guess it didn't even accept retired police officers, right? They would have also had to turn in their their.

And so the San Francisco Retired Police Officers Association was, was was aggressively opposed to this. Interestingly enough, the San Francisco rank and file, like most police rank and file, they're not anti-gun. But the, the the retired guys were definitely actively opposing this.

And then you also had, Pink Pistols, which is a gay rights group that is also a gun rights group that was actively involved.

Yes, we've we've worked with them over the years and they've been very active, locally at the time. What was going on was they didn't have the state legislature under control. It wasn't, you know, a supermajority back then. So you can actually stop stuff at the state level. So there was a big push to pass local ordinances by the what was then the Legal Community Against Violence is a gun control group headquartered in San Francisco, that pushed as part of their local, initiatives, pushed local gun bans, regulations.

And they weren't really I mean, they supported this, but they weren't really the ones behind it. I think they even recognized that it went a little too far or way too far. But this was part of the local ordinance project that the NRA and the CRP put together to oppose all these local efforts across the state. It slowed down since then because the state legislature is now controlled by the Democratic machine.

And so they can pretty much pass anything that they want to push through.

There's the there wasn't a lot of support for this, even among, staunch gun control advocates at the time. 2005, you know, including Gavin Newsom, who was mayor of San Francisco, is now governor of California. Of course, is is advocating for a partial repeal of the Second Amendment.

But at the time, he he didn't think it would stand up in court. And the same thing was true for Dianne Feinstein, who was senator at the time. She didn't think it would stand up in court. And the reason they thought that is because this was not the first time that San Francisco tried to ban gun, a handgun ownership in particular.

Right. Dianne Feinstein herself was mayor in the 70s when this the city passed, a handgun ban, at that time. Right. And that could you just give us a little bit of background on that, just to give people an understanding of.

Yeah, I believe that was in response to the Harvey Milk shooting where one of the city council members went in and murdered another city council member and, and there. And that was Feinstein's response, now a Second Amendment foundation, and I believe the NRA and the, I'm not sure about whether the Crpd was involved, but they all joined forces and filed a lawsuit against that, which was before my time.

That was led by Don Cates, my my friend and mentor, who has since, passed on. But,

That's a local city cannot pass laws that conflict with or or otherwise frustrate the a state law, an intention of a state law. So they're preempted by the state level regulation. So you can't pass a law that duplicates some state law because there's already a law in place that you can't do, one that makes something that the state makes it, you can't make it legal.

And if its state makes it legal, you can't make it illegal. So that was the major argument here, that there's this whole regulation, this whole regulatory scheme at the state level for purchasing, acquiring, possessing handguns that the city of San Francisco's prop age and the earlier Feinstein effort to ban guns conflicted with. And so and so.

The Second Amendment Foundation won that California state Supreme Court case back in, I believe, was the 80s. Yes, against Feinstein's handgun ban. And so that is why it might seem odd that Harris would be the only one of these local, you know, who many people know now as a very staunch gun control advocates to actually support this proposition H attempt in 2005, because the rest of them thought this is just a repeat that isn't going to work.

And I guess that's kind of foreshadowing, because then you guys came along and and you filed your case and, and what was your, your argument and how did that case go.

So, well, I mean, the prop H case was was reset for Heller happened. Yeah. In fact, I think it was decided that the appeals case, I think was finished in 2008. And then the California Supreme Court refused to hear their appeal.

I mean, you guys actually got legal fees from from San Francisco for this, right?

Yes. Yes. For prevailing. Yeah. And that was that was an NRA and CRP case. The Second Amendment Foundation also helped to to bring challenging prop H. So thanks. Let's knock that out. But that hasn't stopped San Francisco from trying everything around the edges that they can do to try and restrict gun ownership in that city, including banning gun stores, you know, basically putting them out of business, banning, self-defense ammunition, lock storage ordinances that, make it impossible to access your firearm.

But if I remember correctly, one of her deputy DA's was the guy who came up with this theory, this legal theory to to get around the Doe, the city of San Francisco decision from earlier when they first tried this. And a lot of people didn't think it would fly and it didn't so, you know, Feinstein didn't jump on board Newsom, probably because he was contemplating running for governor at the time, didn't want to alienate the rest of the state, by advocating handgun bans. But a lot of people just saw this as a creative argument that was a little too clever for its own good, you know?

And and that's what it turned out to be.

The legal difference was supposed to be, according to some supporters of prop H, was supposed to be that it only applied to San Francisco residents, unlike the previous ban, and therefore it was, home rule doctrine and the courts just rejected that. Right? Essentially. Okay. And so, you know, you won that case, but obviously Harris continue to be San Francisco Da for a while.

And she was involved in a numerous, much more involved. That seems, in, a number of other reforms and then obviously became attorney general after that. And you guys have been, fighting her in court over these things for a while. So the next one was, was the, lock, the gun storage ban. This one has gotten into the news recently because there was a clip of her from a press conference where she was, promoting this measure, where she just discussed, the idea that law enforcement would enter people's lawful gun owners homes, locked homes to inspect their gun storage setups because, she was didn't want guns to go this

is a very consistent message from her at the time if you listen to her press conferences. But she had this point of view that lawful gun owners are also a source of crime. Guns because they don't secure their guns properly, or maybe they're even selling their guns, improperly to criminals. But so the next thing that you guys fought with her over, I believe, was this safe storage, measure.

Can you just talk a little bit about that?

Well, yeah, that would have basically made it impossible to to access your firearm for self-defense, particularly, you know, in the middle of the night, when the windows are breaking, you would have had to get to your unlock something to get to your firearm. And the, the the crux of this for her was that she was going to enforce this by doing compliance inspections.

That's what the gist of her press conference was. Fourth Amendment be damned. You know, I mean.

So I don't think anybody, you know, any police entity ever took it seriously, that they could go into somebody's house and inspect for it in compliance with a locked storage ordinance.

Although if they were in the House for some other reason, like a domestic violence call or a fire or something like that, then they could, you know, ask about it, but generally it wasn't something that they were going to set up a big program to enforce

Right. Do you recall, how that case ended up during I think that law was never struck down.

Well, they, yeah, that was that was the state court upheld the lock storage ordinance, but this was again before Heller, which was a challenge to DC's lock storage ordinance, effectively also ban on handguns, in effect. But so this, the state court upheld it. Now, it's been, out overdone, overruled by Heller so that, you don't have the same kind of requirements there, but they San Francisco will just they just keep adjusting the law and trying to, you know, and that was the one that also banned self-defense ammunition.

So, and that's law still in effect. That's that's on our that's on our bucket list of, of of laws, local ordinances that we do we definitely want to challenge in California.

And from there she and that Newsom was on board with that one. Of course that was one that he, he also backed, like the total handgun ban. But from there they went more towards targeting, local gun shows that was then called the Cal Palace outside of San Francisco. Right. Can you just talk a little as.

We're still litigating gun show bans? The the big question most in the, in the San Francisco issue was they didn't own the property. It was a state, property. So San Francisco couldn't really regulate how that property was going to be used. So but then that turned into state laws more recently that banned gun shows on all state property.

So those are those fights are still going on, in the courts right now.

What is the status. Because Harris. Yeah, she there's numerous press conferences of with her and Newsome from the from her time as de in San Francisco where they were complaining about these gun shows. And they were trying to get

the state to stop doing them. And now, you know, that view has taken on more popularity in San Francisco.

Arabs are in California government. But didn't you guys just have a victory and,

Well, a partial victory. You can still have gun shows and you can still offer guns for sale. But weirdly, the Ninth Circuit ruled that the that the acceptance of that offer is not protected by the First Amendment. So we're in the Supreme Court now asking for them to to recognize the First and Second Amendment. And I think that's an important point for folks to recognize that Sanford, San Francisco was just sort of the lead city.

They wouldn't issue concealed carry permits. They wanted to pass all these laws. But it's always been part of Gavin Newsom and Kamala Harris's plan to basically eradicate the gun culture, do whatever they can to they they, you know, they put the one gun store that was in San Francisco out of business. They want to ban gun shows.

They want to make it impossible to open and operate a gun store. They want to make it impossible to go to a range, so, or any other kind of activity that where gun owners discuss gun politics and gun rights and the social utility of firearms ownership. They want to eradicate the gun culture so that the next generation doesn't recognize what they've lost.

And that's all part of all their efforts that that that's sort of the subtext of everything they do.

And really even extending into, the last couple of years. And one deals with, concealed carry restrictions in, in California pre Bruin, right before the Supreme Court weighed in on some of these good, good reason clause, type of restrictions that only allowed people who government officials said had a good reason to need a concealed carry license to actually obtain one.

Well, once we won, once we started winning and saying, you know, you can't just say good, cause basically what some cities were saying was that good cause means you have to have a proof of some stalker, you know, assigned death threat, you know, in order to establish good cause. And so, there were a number of different challenges, constitutional

and legal challenges to that wound up in our Perugia case.

And, she at first one had a hands off wanting to let the local officials, defend it. But ultimately she got involved because we started winning and her position was good. Cause is a very high standard, and almost no one should get a, a license to carry a firearm in public. And, that was a I mean, her DOJ got very involved in that, trying to save that that that case.

And ultimately, in the Peralta case, we won in the three judge panel, but then it was overturned and we asked the Supreme Court to review that case, and they turned it down. So we were we were stuck with that. But interestingly enough, even though we didn't win legally, we won the persuasive battle because a lot of conservative local sheriffs were police chiefs.

Read that opinion. And, and and agreed with it. And so that kind of turned the page before Heller or before Bruen on CCW issuance. And a lot of the red counties in California, which is, which is most of them, by the way, other than the coastal strip. Sure. So so that resulted in a lot more licenses to carry being issued in California.
