But anyway, yeah, at this point, who doesn't know who you are?

Absolutely. Thanks for the invite, as always. I love, get a chance to come on the podcast. So, yeah, I'm the editor at Bearingarms.com, most of the Cam and Company podcast. Been doing this for about 20 years or so. So I think, I think I started covering the Second Amendment full time and in the 2004 election cycle.

So, yeah, I've seen a, a number of these elections and, this is a this is an interesting one. It's going to be interesting to see what happens over the next couple of years.

Yeah. You know, so again, preliminary results, we don't actually know the full makeup of government yet because it's honestly, it's probably going to take another week or two to get the absolute full results because some of these states will accept ballots that are postmarked by Election Day, but don't come in until like a week later. And that might matter in some of these races.

Some of them are going to get to recounts. In fact, one of the the sort of bellwether gun races, Jared Golden's reelection up in in Maine, looks like it's gone to a recount. He's ahead, but, that's probably going to be in a recount as well. So, you know, we don't we we're not going to have probably the full understanding of what exactly how many seats Republicans got in the House or the Senate.

It's right now, you know, it's clear it's clear that Trump won, right. That that much is pretty obvious. And he swept all the battleground states not by huge margins. He was closer there than in a lot of it. But the swing in most other states, towards Trump's. So, you know, it's interesting. It did still end up being fairly close, but it was something that where the

result was pretty clear by the end of election night.

And, and it's only going to be, you know, there's still millions of votes to count, but they're not going to change the outcome. Whereas, the Senate, you're going to have a Republican majority that once that's clear, the Republicans picked up the red state seats that they needed to from, the incumbent Democrats in Ohio and Montana, in West Virginia was an open seat, but that's obviously flipped as well.

And it looks like they're probably going to pick up Pennsylvania so that they get one of the battleground states, for sure. But maybe not any of the other ones, at least. But we still don't know for sure on three of these races, Nevada, Arizona, Pennsylvania. But it looks like Democrats are going to take Nevada and Arizona and Republicans take that swing.

And then the House right now, decision desk HQ, which I think is very reliable. They've called, I think like 216 Republican seats, are already called, but they're still haven't gotten quite to the majority yet. And they're projecting, a 1 or 2 seat pickup. Beyond what Republicans already held. So not really not much change at all.

But but they're holding. And the key takeaway is you're going to have a Republican trifecta in the federal government, but they're going to be with relatively thin margins in both the Senate and the House. So, that's setting the table with all the caveats, I think, that are appropriate. So let's get into what does that mean for gun policy?

I want to just start off with legislation work. What do you see the ability of, Republicans to do on guns through legislation in a Congress that they control, but only by thin margins?

Well, on paper, not much. Right. You know, if the filibuster stays intact in the Senate, which Mitch McConnell says it will, of course, he's not going to be the Senate majority leader. Right. But if the filibuster remains intact, let's say David Cormack is declared the winner. Ruben Gallego is the winner in Arizona. Jacky Rosen is the winner in Nevada.

You're looking at 53 Republican seats, right? So for any pro-gun legislation to pass, you need to get seven Democrat senators to sign on. So, that's that's going to be a chore, right? And I don't necessarily think it's possible, to get seven Democrats to sign on to program legislation. So, you know, I don't know that we're going to see anything, actually get to Trump's desk if the filibuster, you know, remains in place and, you know, over the House side, I think you will see things like, I think we've got a good shot at passing national right to carry reciprocity.

Pretty good shot, I think, at passing the hearing Protection Act. Although, you know, I'm not even sure about that. I've got a piece coming up this weekend that bearing arms looking at right now, Richard Hudson's, Right to Carry Reciprocity Act has 170 co-sponsors. So, you know, you're still 47 votes shy. Now, listen, you know, you don't have to co-sponsor a bill to vote for it, but that at least indicates that there are, you know, several dozen Republicans who are either on the fence or for whatever reason, haven't, you know, wholeheartedly embraced the idea of national right to carry reciprocity?

The Hearing Protection Act, I think, has 69 co-sponsors in addition to the, the original sponsor, Jeff, I think it's Jeff Duncan from South Carolina. So, again, you know, this is a it's going to be an upward fight, I think, for gun owners to get some of these priorities through Congress. And, you know, one of the other things that I'm kind of keen in on here is that even with Republicans in control, let's say we've got a Republican trifecta.

Gun owners are still going to have to lobby to be heard. Gun owners are still going to have to lobby to say, hey, pay attention to these issues here, right? I mean, you can go and you can look at the 2024 Republican platform, very light on, you know, gun issues.

Yeah.

So they stripped out, you know, specific policy, promises that had been in the previous, platform for the party. Right.

You know, again, trying to fundamentally restructure, the executive branch and, you know, cabinet agencies and things of that nature. And otherwise, you know, we may very well get overlooked.

And and the thing about the top priorities, top legislative priorities, the gun rights movement have been the two things you mentioned for forever.

Now, the, national reciprocity and hearing protection and, you know, national reciprocity, you're going to have

pushback from potentially Republicans in blue states, because essentially, what national reciprocity says is that those blue states have to honor everyone else's permits. And and a lot of people in the blue states don't like that. I mean, more so on the Democratic side, obviously.

But you you do wonder where some of those blue state Republicans in California and New York, especially in new Jersey, are going to come down on that. But, you know, same thing for Protection Act, you know, center reform, anything dealing with the NSA as much as that animates online gun rights activists, I don't think it animates a lot of Republican congressmen nearly as much. But your average Republican congressman, I don't even know that they have any understanding what the NFA is to begin with.

Right. You know, and I mean, again, I think that's one of the challenges, right? That's why gun owners just can't take anything for granted. Now, even as the filibuster remains intact, you know, there will be some opportunities, I think, to do things through reconciliation, through budget bills. Which is a simple majority. But as you say, right. Then the issue becomes, okay, how do you get 51 Republican senators to, to say, okay, this is this is what we want to do here. How do you get 217 Republican, House members to say, this is the argument that I can take home to my district, in a blue state like California, right in, in a, an election or a district where maybe the Republicans won by just a few thousand votes.

And, I think the guy's name was across this, and he said, he could see, you know, Congress saying, okay, well, we need to make some changes to the gun laws in DC before we allow you to do something like that.

So, yeah, I mean, it is possible that, you know, even if you don't get national right to carry reciprocity, maybe you get universal recognition in DC, maybe, you know, that might be a demand that, Republicans put out there that if you want, if you want, you want us to allow this new stadium to be built. Well, we want to make sure that people don't lose their second rights when they come to our nation's capital.

I do think that that I agree with you as far as like budget reconciliation, putting things like the hearing Protection Act or national reciprocity or DC gun mall changes into larger deals where they're much smaller pieces of a larger piece of legislation, and those seem more like the realistic ways if, assuming things stay normal.

And over the last couple of years of the Trump administration and even during some of the Biden administration, because of Trump's appointments, we started to see three judge panels, on the Ninth Circuit, say, this gun law. No, this violates the Second Amendment. They didn't have those on bonk reviews that would overturn those decisions. I think we actually did get a good decision in the Boland case.

Right. The case dealing with California's handgun roster got a good decision from the three judge panel in the ninth Circuit. Did not take that case on bonk. So that is, I think, a significant win for gun owners. Right. But that's going to be a huge part, I think, of Trump's second term is, again, shaping the judiciary, not just at the Supreme Court level, but at the district court level and at the appellate court level, too.
