But we also just got some polling from Gallup that is kind of interesting. One one of the polls they released dealt with, support for handgun ban, and support has fallen back near all time lows.

It's only 20% of the population, but supports the idea of banning possession of handguns, except for, law enforcement. And the particularly interesting thing about the tre crosshairs in that poll are that Democrats are the ones who drove that support back down. And then, to actually almost, almost 50% was the 49% for Democrats last year. And this year it dropped significantly by double digits, which drove this support for a handgun ban back down. And I think it's reasonable to look at the campaign and draw some conclusions that the poll doesn't specifically ask this, but I think it'd be hard to not notice that the Democratic presidential candidate was running on the fact that she owns a handgun, a Glock, and that that, probably played some role in this movement.
