What? What are the first question we got there?

Sure. Yeah. This one's a, sort of a Supreme Court related question asking about the current state, assault weapons ban challenges and which case might reach the Supreme Court first. I think we have a general consensus, both you and I, about which one that might be, the snow case out of Maryland, right?

Yeah. So, you know, let's set the the landscape here for all of the members sent this in. You know, obviously there are a lot of assault weapons ban challenges percolating through the federal courts right now, some of which have already gone up to the Supreme Court. Right. They've already tried to get, cert at the Supreme Court and, have failed.

We just covered Illinois case, with their recent Lee enacted, assault weapons ban in Illinois. And they, the plaintiffs there, the gun rights plaintiffs tried to get the Supreme Court to get involved, but the court said no. And we got we got a message from, Justice Thomas, sort of explaining maybe some of the reasoning involved there and which does, I think, point to snow as a better vehicle for this, a more likely case to actually be the one that the Supreme Court takes up.

And why was it what a Thomas said exactly.

Yeah. So it was a case that was before the Supreme Court, after the Seventh Circuit had denied a preliminary injunction against Illinois's ban. So it was that the preliminary injunction stage, which means there wasn't a final ruling on the merits yet. And after the court denied cert, Justice Thomas wrote separately, basically just to say, yeah, I understand our decision today to respect basically the lower court procedure because this is an interlocutory posture, aka it's not to the final merits ruling yet.

That's why we're going to send this back, however. And then he went to went on to expound about why he thinks it's just about high time for the court to weigh in exactly what the second what kind of arms the Second Amendment does protect. And he took a couple pot shots at the Seventh Circuit's ruling. And there's sort of the rationale for denying the preliminary injunction.

So he sort of tipped at least his hand as to, how he feels about these types of bans and his appetite for taking one.

Yeah, he basically said he thought the Seventh Circuit was wrong and right. The most popular rifle in the country, leaving being the AR 15, which is broadly targeted by these types of assault weapons, so-called assault weapons bans. While they even though they may vary in their makeup from state to state, what an assault weapon is in Illinois is different from one.

So up in is in California, for instance, or Maryland, which is where the Snopes case is out of, but they all try to target similar guns and most prominently, the AR 15. And Thomas made a comment to the effect of, it wouldn't make a lot of sense for the Second Amendment not to protect, the most popular rifle in the country, given their sort of common use standard that they set up in, or articulated in Heller, sort of set up in, in Miller before that.

But regardless, yeah. So we have Thomas's view and we have, you know, breadcrumbs as we're always trying to read

entrails and follow breadcrumbs when we're talking about Supreme Court. Right. Because, until you get to that final actual opinion, you're not going to necessarily have a full understanding of exactly what goes on inside the Supreme Court. That's just how it operates.

You will get sometimes what a what one justice thinks. And perhaps an influential Justice Thomas, wrote Bruen. After all, the landmark case from 2022, that set up the new standard for judging second in the cases, although he was the single to center in Rashmi the court's last second in a case. So, you know, I don't know if people can guess themselves whether he's the most influential or the least influential.

Justice on on Second amendment. Jurisprudence at the court right now. But he did put, you know, here we got his view. No one else joined on that and is you, frankly, is somewhat similar to what we saw from Justice Alito in the Antioch case in New York. The one that dealt with this broom response was the new gun carry restrictions that New York put into place.

And, the court was asked to intervene there at an interlocutory stage as well and said no. And Alito, again, in a similar message, said, this doesn't mean that we don't agree with the plaintiffs on the merits. It just means that we're not taking this case right now. And so they seem to have been pretty hesitant about taking any case on Second Amendment that isn't at the final merit stage.

And that is why. Right. We think Snopes has a real shot of actually being taken up.

It's that and they seem to have a preference for wanting any cases that come up before them to have considered Rahimi because you've seen them DVR a couple of cases that haven't considering me, but this also works in this. Nope. Cases favor because the Fourth Circuit on Fourth Circuit handed down its merits ruling upholding Maryland's Sullivan ban. Several months after Remy was decided and Remy was incorporated into the opinion.

And so all of that is taking care of all of that is off the table. And it is now before the Supreme Court. And as of yesterday, we're recording this on Tuesday, the petitioners in that case, filed their final briefs. So all the briefing is done, and it's sort of at the point now where the Supreme Court can consider it during conference or can release it if it chooses to.

But basically, the ball is in the Supreme Courts Court, so to speak, as to whether or not they're going to, decide to take this case. There's really there's no other obstacles other than they just don't want to at this point.

Right. Other than they might not actually want to answer this question yet. Right. They might not have enough of a consensus on the court to answer this question yet. Now that may sound surprising. I mean, We'll have to see. And I would note to the Thomas dissented when the court denied, the a sort of a pre brewing concealed carry case out of, out of California years ago and he made a lot of the same points that he's making. Now. This is what you know, Thomas has famously, described the Second Amendment as a second class right.

Or at least the Supreme Court's treatment of it as, as such. And, you know, when he did that in the California concealed carry case, you know, Brune wasn't necessarily the very next case they could have taken to resolve that. They did eventually take up a case to resolve this question, which was brewing, which resulted in a landmark, pro-gun.

I think it's fair to describe, ruling, but it didn't necessarily happen immediately after, Thomas made his statement in that case. So it's, you know, it Snopes is set up to be what the court is looking for. That doesn't necessarily mean they're going to take that that. So we'll we'll have to see. But yeah, we have another question here from that sort of follows on with that from another member who wanted to remain anonymous, but basically they're, you know, they ask a question, they know essentially that there's there's differences between California's assault weapons ban, as I was just mentioning a moment ago, there are differences between all these solvents bans.

Right. They they will sometimes define what an assault weapon is differently. You know, you generally speaking, the definition includes semiautomatic, rifles or shotguns or handguns that fire, center fire ammunition and then have a can accept a detachable magazine and have a series of features over either one feature or two feature on this list of of banned features.

That's usually how these laws are written, although they have some states like California, Massachusetts have added on other requirements like copycat designations. If the state thinks they're too similar to a gun they're trying to ban, and they will say that is also banned, these bans usually also have a specific list of guns that they think, are assault weapons.

And so, in the end, you get, frankly, a pretty wide variation between, like, Maryland's two feature ban and California's one feature, plus all the ten years of them trying to, go after workarounds, basically, featureless rifles and things like that. So that you end up with pretty distinct and different lists of guns that are actually banned in practice in these states.

And so how does that play in when, you know, if the court takes up one of these solvents, in case, let's say they take up the Maryland case, Maryland's science ban definition is pretty different from California's at this point or Massachusetts. So, this member asks, you know, what? If Scotus strikes down Maryland, for instance, ban or some other states, could that apply to the bans and other states?

Because, they say I could see California arguing that such a ruling would not apply to states not ban the same exact kind of guns. So what are your thoughts on that? Jay?

Yeah, I think I see what he's getting at, but I think almost certainly it would still apply. Now, that's it's almost a separate question as to whether California would try to work around that ruling or not. That's almost a separate piece of this. But just as, sort of an analogous situation, the Bruin case. So that case dealt specifically on the merits with New York's concealed carry law.

But because, you know, 7 or 8 other states had similar may issue regimes you saw in the immediate aftermath, of that Bruin decision striking down New York's May issue carry law. All of those states, basically their attorney generals issuing opinion, saying, you know, our laws are very similar to New York's. And the Supreme Court just said that that was unconstitutional.

So we were going to amend our current law to comply with what the Supreme Court said. And that's essentially, I think, the situation you would get into in this hypothetical scenario in which Maryland's ban on air fifteens and other rifles is struck down.

Yeah, I think that's exactly right. And I think that the Bruin case, with this, may issue concealed carry laws is a perfect analogy of how this would work in practice if the Supreme Court issues a ruling that strikes down Maryland or Illinois or one of these other states that has cases pending, Delaware, cases pending against their Sullivan's Bans, if they strike down one of those laws, it will almost certainly affect all the Sullivan's Bans throughout the country and any potential federal ban in the future.

Because it's going to likely include reasoning that is more expansive than just the this very specific definition instituted by Maryland is unconstitutional. And we're not going to say more beyond that. It'll probably be a bit more expensive than that. And, you know, protect things like air fifteens outright, from, from wholesale bans on, on their sale or, or possession or what have you.

So it's unlikely that if the, if the Supreme Court does strike down and Sullivan's ban somewhere in the country that other solvent bans are going to survive, that what is more likely as you like now laid out there, though, is they will come up with some other restriction that they argue complies with the ruling. But, you know, isn't technically an assault weapons ban, right?

This is exactly what you saw after brewing the broom response laws. Some of them ended up more strict as far as, gun carry than than the May issue laws were because under the May issue regimes in a lot of these states, if you could get the permit, they were relatively, in line with the rest of the country on where you could carry your gun and the brewing response bills for the most part, have, made it so that more people can get a permit, but made it much, much more difficult to legally carry it anywhere, carry a gun anywhere.

California especially, but most of them, they added the, the so-called vampire rule, this, this idea that, that kind of an inverted how, publicly accessible private property had been treated in the past by saying all publicly accessible private property is off limits to carry unless the owner posts a sign or tells you somehow that it's okay to carry there, which in practice makes going out in public, with legally, legally going out in public hearing a firearm almost impossible,

especially combined with a number of the other restrictions on like, parks and government buildings and, and, public transit, things like that.

You know, they, they ended up with regimes that were actually, harder to comply with. Than before the ruling. So that and a lot of them are still in place right now. You know, this goes back to what we were talking about earlier. Like the court's reluctance to take up Second Amendment cases, an interlocutory state where if you're not, you know, if you're asking for a preliminary injunction and you don't get one from the lower courts, sure seems like Supreme Court is not going to step in and help you out on any second in a case.

And that was one of the first cases was Antioch in in New York on on these new gun carry restrictions. And the court did not step in there. They did. You got alito's statement that basically said, you know, we'll keep an eye on this. And the second circuit should move quickly, but, we're not going to take up the case.

So, yeah. So I think that's what's likely to happen in the scenario where the court strikes down one states us all and ban all of them are going to be impacted, but they will likely find some other way to restrict those types of guns. The, frames and receivers rule from the ATF. They're they already had oral arguments and that we're just waiting on an opinion. I just sort of, straight liability question whether whether Mexico's argument is even viable.

Under, you know, basic standards of law in the United States. So that's, they're even now they're taking fewer and fewer cases overall, but a larger percentage of them have been gun related. So anyway, that's where a lot of, like you said, a lot of the action is there. And, so our next question is from our good man, Weird Beard, who asks, what do you think the next second Amendment case is going to be?

And when? So, why don't you give it a shot? We already talked a little bit about Snopes. What do you think? That's the best chance for the next one? Or do you have a different thought?

It's a question that at least two of the conservative justices think it's time for them to take.

So it's certainly up there. Outside of scope, my money is really on a felon in possession case. And so the DOJ came to them with a handful of hand-selected cases ranging from nonviolent felonies to violent felonies and said, please, for the love of God, Scotus, we need guide guidance on this question. And the Supreme Court said, well, the best we can do is a grant record and remand.

And they kicked them back down to the circuit courts. And we've already seen 2 or 3 come back with the exact same outcome. Yeah. It's basically saying there's no, constitutional application of the felony possession ban. Right. Now it is it's more challenging from just reading their briefs. It challenges the permanent nature of the ban, which is an interesting question, because that that is something that, was sort of implied by Rahimi, that maybe they don't think that the permanent nature of the ban is a good idea, because Rahimi goes out of its way to talk about how the, domestic violence restraining order ban is temporary.

Right. There was some question about whether how temporary it really is, oral arguments. But that was the conclusion the court came to that that was a significant part of their ruling. So I don't know, maybe they got traction, but yeah, it doesn't feel like, looking through the case, the plaintiffs here or the defendant, I guess, is trying to get charges dismissed against him for felony possession.

Whatever his felony was, it doesn't it's not laid out in the briefs, but it's something that had, like, 207 months of incarceration as a punishment. It was probably a very serious and I would imagine, violent crime. I don't know that for sure, but but my guess is he's not going to be a similarly sympathetic plaintiff like ranges.

The guy who lied to get food stamps, in the 90s, for like \$2,000 worth of food stamps. And now he can't own guns forever. That's obviously a bit more of a, sympathetic plaintiff. Which, you know, whether the court cares about that aspect or not, as they probably shouldn't write any of all kinds of landmark.

Civil rights cases where the plaintiffs are not good guys. Miranda nights is the guy who, you know, gotta get us the reading of rights. It probably will be range or some of these other ones that both the DOJ and the gun rights plaintiffs want to be heard. Although you do wonder if, the new administration changes tact on any of this. It is literally the gun control law. Like, this is what the vast majority of federal gun crime prosecutions are for felony possession. Right? So I don't you know, maybe they'll take a more nuanced view, and especially given that the president is a is a convicted felon, who can't own firearms and was convicted of a nonviolent, obviously nonviolent crime.

Maybe he will have a his he and his department will have a different view on that particular question of dangerousness and violence, you know, being required for this, for this ban. But, I guess we'll see on that point. Nobody, nobody is down to that. Yeah.
