We've got, some really interesting developments that have just come out the end of 2024, and it seems like it marks the end of an era for the NRA and the possibility for maybe a new start for the organization.

Now, I am. And this is the, the, board meeting that we scheduled. And, I'm down there right now working, and, it's been going pretty well. So that's where I'm at today. Yeah.

All right. And so, yeah, we'll we'll get some updates for you from you, on what exactly is happening at the meeting. But first, let's start with some of this news that we have obviously, last month, the, the judge in the New York civil trial, against the NRA, issued his final order. That sort of cemented some of the internal reforms that he's, wants to see implemented at the NRA, but also the fact that, you know, the NRA is not going to be dissolved.

It's not going to be under a government appointed, monitor. And, and then also we just got news, a few weeks after that, that the relationship between the NRA and its long time outside lawyer, Bill Brewer and the Brewer firm, is coming to an end. It's it's, the two are moving in separate ways, and, so it kind of puts, I think, a period on this era of the NRA to this, this six year long struggle, since corruption allegations were first made public against former CEO Wayne Lapierre.

And, you know, this this civil trial began, right? I mean, half a decade ago. Right. And so, you know, if you've been somebody who has been highly critical of Lapierre.

Brewer, so I'm interested in your thoughts on this moment now that you, the NRA, has reached, you know, you're on the board. There's a number of reformers in leadership position now. What do you make of this period in time and and of this, new era potential for the NRA?

Yeah, there's so much to talk about here. It's really an exciting time for us because this, this lawsuit with the New York AG has come to a close. The final order that was issued by the judge actually was very reasonable. And it's some things that we probably should have done anyway. So things like internal to internal audit and having some controls in place.

So the NRA actually did really well with this lawsuit. And there was no punitive actions. There were just things that from a compliance standpoint or from a good governance standpoint, we had to implement. So it really was, in, in a lot of ways helpful. I think. I didn't I didn't appreciate how much money we had to spend to, to get to this point, fighting the New York AG's office.

But, the result is a good one. And we're very optimistic about the future. There's a sense of relief. I mean, I'm interacting with all the directors now, this weekend as I'm, I'm in Fort Worth, and, there's a sense of that. So there were so thrilled it's behind us. So now we can focus on the core mission of the NRA, our programs, all the good things that we're working on.

Some of this money that was misdirected under his watch. Same for the former NRA treasurer. What he Phillips. And, so, but but the organization itself, while it was found to have not done enough to protect whistleblowers, wasn't ordered to pay any sort of financial restitution. In fact, the money that Lapierre and Phillips are ordered to pay is meant to go to the NRA as an organization.

That's well, that's correct. And so they you know, I had no punitive financial penalties or anything like that. We have received, the full payment from Wayne Lapierre on the money that he was assessed at, during the trial. So it's almost \$5 million. Oh, really? Yeah, we've received that. And I and the New York AG's actually been tasked with collecting those monies because they were the plaintiffs in the case.

And so we're still waiting to receive, the moneys from the Phillips, order and also from Josh Powell. So, but the Wayne Lapierre moneys have been received.

That's Josh powers, the former chief of staff. Right. For Lapierre also ordered pay, I think \$100,000. That's the settlement with the AG. But but, you're saying that the wop here, money has already changed hands, you see? Sent it over the internet?

That's correct. We have received that. And it was paid directly to us, even though the New York AG was asked to collect it, it was actually sent directly to us. We've received that. And so that part has been resolved with that. Wayne Lapierre.

Interesting, because I know there was some controversy over this at the end of the trial, where, the Brewer firm representing the NRA at the time was saying, you know, they wanted more flexibility in being able to create a settlement, perhaps with Wayne Lapierre. There was some concern, I know among reformers that the number might get pared down.

And Brewer's jurors concern seemed to be that the AG might stretch out that process of of collecting the repayment, because she's shown, obviously, some political animus towards the NRA and her friend, put it lightly, I guess, but, but it sounds like this is that particular part of this is now completely resolved in full payment.

That's correct. It's completely resolved. And there was a lot of things at the end of the trial there that actually Wayne Lapierre, his lawyer, was trying to, have the court move the negotiations for settlement to the NRA as opposed to being handled by the New York AG. And it was right. It was it was correct to leave it with the New York AG.

They were the plaintiff. They brought the lawsuit. And so they were tasked with that. And but we've gotten full payment. We're excited about that. We can kind of close the chapter on that whole story, and all the things that went on there. And I'm glad that part is over. I mean, this has been a long, a long haul for just.

You know, and and speaking of which, I guess there there are still some, I know there are some reformers who would like to see, some of the legal expenses that the NRA paid, potentially in support of Wayne Lapierre to be called back as well. And have you heard anything about that? Is there any discussion of doing that at this board meeting?

And as the CEO of the organization, the NRA was in fact paying his legal expenses. That was at that point, he was not proven guilty.

And they were, you know, trying to get to the bottom of that. So we did pay for those legal expenses all the way until the end of the January trial, which was phase one of that trial. And once he was proven to be actually found guilty, NRA stopped all payments to cover any legal expenses and also any salaries and all those kinds of things.

Imagine that's it's a lot of money then that probably, went towards paying his legal bills. Is that and so that I guess is what people, at least some portion of the board wants to try to claw back. Do you think that's a realistic possibility here on the ground there in Texas?

Well, you know, I, I don't know exactly what that number might be, but as you can imagine, when you're anytime you're talking about legal expenses, they're always going to they're always going to be high. And so there's going to be significant money associated with, with, defending Wayne. I haven't heard any, action taken on that matter. Other than I've heard the discussions.

I mean, I've thought about that myself. You know, that there's additional expenses other than just this penalty that was paid. So. But that's something that the board needs to look at and see. Is it appropriate? What? You know, what's the ramifications? How do you do that? What's the process and that none of that has been decided. That's that's something that I'm sure will be discussed at some point.

And how much is do you want to see people move past it and just try to, focus on writing the organization? What are your feelings? The the trial is settled, but not every, you know, wrongdoing has been corrected necessarily. Right. What are your thoughts.

And one of which is actually the New York law states that if, their expenses incurred or money is expended, on an employee of an organization, of a charity, and they're, and they're, they're, mis, applied incorrectly in the like, for example, in this case, you must make every reasonable effort to reclaim those expenses.

So it's really not a matter of in this particular issue. It's not a matter of, well, do we want to do it or we don't want to do it, the losses that we must. So, I think when, when this issue comes up, that's the first thing that the lawyer is going to look at it. We have a legal obligation, not only as a as a fiduciary, but also that's what's stated in the New York law.

So this issue is going to be discussed. I know it's going to come up and we're going to have to follow the law. And I can I can, I can email you the, the law that, that states that, that particular issue. But, it's, it's in the statute. So we're going to have to pursue that. Yeah.

Okay. And there, there are going to be a couple of other things are going to have to, sort of tie up loose ends of this, this final order. There's still stuff that you guys have to do, like picking a consultant, that the court then has to approve. It's not court appointed like a monitor, but it's there's a consultant who's going to essentially help with internal controls.

You know, you have a number of, changes that have to get enacted to comply with this order, right, that also deal with, you know, internal controls and internal auditing, and oversight, so, you know, that I imagine it's still going to take a little bit of time is that that's part of what you're doing here at this board meeting.

Rocky Marshall So I know the lawyers and those groups, the committees that work on those issues, are digging into that. And I believe they're trying to get all of those issues buttoned up by the end of this meeting, this weekend. And so that we're in total compliance with the court order, which was just issued, you know, in October 31st.

You know, that's probably the the biggest thing. I mean, there are some cleanup things for sure. I mean, the board will meet, actually on Saturday, the this week is all committee meetings. So, all the committees and all, you know, different programs, all those things are happening this week. But on Saturday, there will be the, the board meeting and there's still some cleanup.

I'm sure there's some things that are going to come up that have to do with this trial that, or kind of what I would consider housekeeping kind of items. We're talking about a whole new set of programs on how to to, recruit, new members to the NRA.

Well, yeah. And I think, I think a lot of things that held the NRA back. True. Was this New York AG case. I mean, it just was in the headlines. I mean, I wrote about it. You wrote about it.
