So what was your takeaway from this when, you know, that was the first day there have been, we're on Friday. We're recording now. Obviously, usually you judge a president on the first 100 days rather than the first five days, but, you know, he's trying to come out swinging and, I don't know, what do you make of, how the, I guess, inaction on on guns through this first week.

Trump's always a special case, I suppose. So he always has to be kind of judged on his own terms. Trump historically, in his last administration as a candidate, is someone who is very, very energetic when it comes to rhetoric and creating drama and this kind of performative politics, he is a lot less, active and dynamic when it comes to actually getting things done.

And that's historically been just kind of his pattern. He likes to stir things up and have confrontations that play out in the media and, and conduct himself in this sort of histrionic way. And then you'll often see, lack of follow up on that. Part of that has to do with the fact that in spite of his self-proclaimed role as a great negotiator, he actually has a really hard time working with Congress.

And there's only so much a president can do, on his own. So hence the flurry of executive orders and pardons and commutations and those things. So if you think about the main thing he did vis-a-vis gun rights on day one was restoring the gun rights of 1600 people who were felons and probably shouldn't have had their gun rights restored, including people who committed violent crimes and attacked cops and things like that.

You know, six people.

He said that he was not going to, extend clemency toward, he had said he was going to do this on a case by case basis and look for people who were treated unfairly. J.D. Vance came out and said the same thing as recently as the Sunday before. And, of course, what he did was he took the lazy way out of it.

He just made a categorical decision about all those people, rather than actually doing the work of reviewing the cases and saying, all right, well, maybe this guy was, you know, granddad who was there as a protester who got sort of swept up and carried into the capital by the crowd versus this guy who was obviously, you know, a malefactor with ill intent beforehand.

Now, any of the big things that you can get done in terms of really reforming the ATF, reforming the way in which we go about, regulating firearms, investigating gun crimes, dealing with violent crime involving firearms is going to require, not only congressional buy in, but it's really going to require bipartisan buy in because no sort of big social policy that is a durable, lasting, you know, meaningful reform ever happens without bipartisan consensus.

Trump obviously has some of the same instincts and, habits, which should be, resisted, I think. That being said, one of the things I worry about is that the gun rights movement is a little like the pro-life movement, in the sense that it's become a bit of a cheap date, for Republicans. So there was a time when the National Rifle Association, for example, was a genuinely bipartisan group, and they would work with people who were good on their issue, irrespective of whether they were Democrats or Republicans.

So, the gun rights movement, I think requires, either a national Rifle Association or another organization that will be less, reflexively Republican and more open to being critical of Republicans in power when they deserve it and more focused on their issue. I mean, really, the main problem with the NRA is that they've, they just care about too many different things right now, including sort of building media careers for people who who work at the NRA, which is kind of a bad phase.

And then when it gets to actual specific policy, he's a lot less, prolific in talking about that.

And the only thing he really did, in my estimation at least, is, he has promised to sign some legislation, like the national reciprocity. You know, he is not someone who has, a lifelong interest in gun rights. And on the opposite side of a lot of issues from where he's landed, when he decided he needed the Republican Party as a vehicle for his, personal ambitions.

So Trump's commitment to gun rights is, I think, questionable. And it certainly transactional, I think is a fair way to put it. The NRA spent upwards of \$50 million in the 2016 election, and was one of the only major outside groups to really forcefully back him with, both rhetorically and with money, with spending and organizing and campaigning.

But, certainly there that aspect of what they've been able to do for Trump really waned the last eight years. Right. So do you think that's at play here? Why this is not coming up on the priority list? Why? You know, we don't see a big gun, even even something fairly symbolic that might not hold up.

I mean, like, like you mentioned, a lot of the Biden stuff was questionable from day one, that it would hold up in court when he went and did it, but he did it because he wanted to show favor to the gun control groups that were backing him in. There's also the industry, the manufacturers, importers and retailers, firearms. And they generally, of course, support gun rights as well, too.

But they also have a very strong interest in having a stable policy environment. They want to be able to predict what their business environment is going to look like going forward. couldn't do it because that'll be resigned ahead of him coming in.

What do you think Trump is going to do with this position, and what do you think he should do?

Right? We've got issues related to organized crime and to kind of non organized career criminals, you know, people who commit the vast majority of violent crimes in the country.

And we've got other issues related to, other contributors to that kind of violent crime. The United States. And our main thing we've been trying to do is deal with this through an agency whose main task is regulating sporting goods stores and, and regulating a handful of small to medium sized manufacturing companies. The link between the one and the other, of course, is just not very strong.

You know, the whole premise of, our model of regulation is that we can deal with these things by dealing with the point of sale at licensed firearms dealers, which is where the vast majority of ATF's effort is, is focused. And, this has very, very little intersection with violent crime in the United States. As you know, most people who commit violent crimes with firearms do not buy them from stores, because they can't because they're already criminals who are disbarred from buying firearms for one reason or another.

The last time I checked. And these numbers are maybe 3 or 4 years old, of the people currently incarcerated for crimes in the United States, the ones who had a firearm on them at the time of their crime, which is only about half of criminals to start with who were incarcerated. The number who got that firearm from a retail source is like 2.5% or something like that.

It's a very, very low number.

So the numbers crimes are also felon in possession crimes and not even necessarily connected to a specific separate crime.

So some of those may be felon possession, some of them may be armed robbery. Some of them may be something that didn't have anything to do with the gun at all, but they just don't have a firearm on them when they when they committed the crime.

So what the administration needs to do before it can even begin to enact some sort of ATF reform agenda is answer that question that I've been trying to get you, which is why do we do it this way?

Why do we have someone who's basically a business regulator also doing organized crime, or an organization that really is going to be focused on organized crime, but also as a regulator of sporting goods stores? And to figure that out, you have to really think, take a step back further from there and say, what should be the goal of our regulation of firearms at the federal level? I think this is a question that could be devolved, in part, I think, that state and local authorities are almost certainly better positioned in the long term to be the lead regulators, on this than the federal government is, the federal government sort of fell into it because it's a, partly because it's a relic of the Progressive ERA, which had a lot to do with the centralization of, of power in the federal government.

One of these models of regulating, public events is consistent with the First Amendment. And the other one is and they're both consistent with First Amendment, one's more restrictive than the other. There's a good case for having a more restrictive version in midtown Manhattan in there is for rural Wyoming and I think it would be a perfectly sensible thing to have, appreciably different, regulatory regimes, not only for purchasing, but also particularly for carrying firearms in different states and even down to the municipal level.
