That is what's best place to go and do it. This week we are going to be talking about, Donald Trump's firearms executive order that he, he issued, just recently here. And we want to get into some of the details of what this might turn into, some of the policy areas that this might have an impact.

Thank you. Well, we we always appreciate you coming on. Given your insight as a Second Amendment scholar here. Can you tell speaking which can you tell people a little bit more about your background? And just for anyone who, doesn't know the full details?

Sure. I'm the research director of the Independence Institute, which is in Denver, Colorado. And it is. I've been in that position since 1992. I started writing for them in 1988. Independence Institute is the second oldest of the state level think tanks. I'm also a. Excuse me. Oh, I'm also an adjunct scholar at the Cato Institute in Washington, DC.

So you have a very good understanding of federal, firearms law and policy. And and so I'm hoping that we can go through this executive order, which really, you know, at the moment, all it does is order a review from the attorney general to go and look at it some, really, but it is kind of the top priorities of a lot of the gun rights movement, what they

want to see the executive branch do in this administration.

But it is at the moment just a review. And it's, you know, the it doesn't flesh out a lot of the details. So that's what we're I'm hoping to accomplish here. So there's at least seven areas that the AG is supposed to focus on. Now some of these are a bit redundant, right? Like the first one talks about all presidential and agency actions during the Biden administration, essentially, that, purport to promote safety but may have impinged on the Second Amendment rights of all citizens.

So that's kind of a catchall thing for all the later rule, later subsections. But the first one is rules promulgated by the Department of Justice, including the ATF. So can you just walk us through what you see as the possible not not necessarily exactly what's going to happen, but some of the possibilities from that first section there, the rule, the ATF rules that we saw from Biden ministration.

Well, let's see, they've, they lost on their, on their, well, that came from the Trump administration, but then further by the Biden administration, was that the bump stock rule? And that's obviously been held, unlawful, by the Supreme Court in, Khalil of, Garland v Cargill. The Supreme Court didn't rule on the Second Amendment issue, which would not be a winner on that particular, topic, but said it just doesn't match what the statute says.

Right. There's been a ton of, ATF rulemaking, by the Biden administration. Most famously, I suppose, the pistol brass rule, which is it's long and confusing, but it seems to say that most pistol braces are presumptively unlawful because they convert a gun into a short barreled rifle, which under the National Farms Act, you can own, but you got to pay a \$200 tax and go through a registration procedure.

And then there's also a, a making rule, which is currently being litigated. But that aims to, at the least restrict, the manufacturer of a firearm at home for personal use.

As far as can be, you know, gun making, homemade gun kits. But yeah. So those are the two, I think biggest ones that people have heard of that have the biggest impacts, in real, you know, in real terms, at least in theory, like the pistol brass band, there were millions of those guns.

court. Right. You also have, for instance, the, the used gun sales rule where they tried to, you know, make a new rule that implies many, most people who are selling used guns ought to get a federal license to do so.

And that's. Yeah. And that that's also a, a troublesome one because it's always been. And by the way, on on the, the making thing with, you know, 80% receivers and all that, that's currently in front of the Supreme Court and they've had oral argument. Right. And I would say based on that, I'd expect the government to win that case.

It does seem to lean that way. Yeah, yeah. Actually, a question on that. I don't know, maybe, you know, this may be outside of both our areas expertise, but is there something that could even actually do at this stage now that oral arguments are over and we're just waiting on the court to deliver an opinion with the so-called ghost gun rule, is there anything that the Trump administration can do?

I think, you know, the the, I don't think that's going to happen, but the attorney general could say we, you know, we petitioned for search warrant. You granted it, and you did everything. But we'd like to let you now know that we, we confess here, and we were legally wrong. So if you let us withdraw the case, as well.

And I think that's actually one that that might have the most practical impact on people, you know, the general rule on by congressional statute and the Gun Control Act, as amended by the Farms Under Protection Act 1986, is you need a federal firearms license if you are engaged in the business and engaged in the business means repetitive activity, for profit.

So, you know, if you're going to gun shows and flea markets, running a table there and over the course of a year, you by 23 guns and you resell 20 of them, over the year for a profit, then you're plainly engaged in the business and actually president of, Obama, in a sort of flurry of executive and regulatory action in January of his final year in 2016, came out with a ATF, interpretive guideline on that, which was actually that despite all the uproar, you know, in a Partizan sense,

it was it was a perfect explanation of that rule and its correct application and and what it also means is if you,

you know, you have 15 guns and your wife says, we need some money to, to go on vacation in the summer. So why don't you go to the gun show this weekend and sell a few? The husband does and sells three guns. That's not a that's not repetitive transactions. And he's not engaged to the business.

There might be state laws. Well, there will be state laws that apply to that. But he doesn't need a federal firearms license, to do that kind of one time occasional thing. But what the new Biden rule seems to say is, if you ever sell a gun for a nominal profit, then you're supposedly engaged in the business.

Which has seen the number of license revocations increase quite significantly during the, the end of the Biden administration.

And and this is really just abusive stuff. It's you should take away the licenses from gun dealers who are, you know, for example, selling guns off the books.

And so a a real white House Office of Gun Violence Prevention, might take an advocacy role, and criticize laws such as in New York or Hawaii that basically say, well, we'll give you a carry permit.

All right. So the next thing from there is, and this one could be pretty soon. And that's that that's longstanding. And and it's still that way, on gun cases, the then you've got the question of when there's a, you know, affirmative lawsuit filed by the NRA or the Second Amendment Foundation or gun Owners America Firearms Policy Coalition groups like that, that challenge a federal law as violating the Second Amendment. And so there's, a number of cases right now challenging the ban on 18 to 20 year olds, buying handguns from felons.

And, and there's a whole bunch of cases that are direct attacks on the Gun Control Act statute, the norm arm of statist state attorneys general and the United States Attorney general from time immemorial. And that's even true of the attorney general can say, you know what? This might have been okay, under the precedents that existed 30 years ago, but the Supreme Court's been going in a different direction. And I think if we defend this law, we're going to lose, the general approach is fine. Go, go ahead and lose. You know, but just like every felony defendant gets a lawyer who will speak up for him, every, every statute, gets an attorney general who will defend it.

You know, and that was and that. And I'll say to the Biden administration's credit, when there were cases involving plaque at the protect 2005 Protection of Lawful Commerce in Arms Act, which outlaws many of the abuse of lawsuits that were going on against firearms manufacturers and stores. Biden hated that bill, fought it in the Senate and as president campaigned against it and as president repeatedly and often in it, accurately, denounced it.

So, and I think what I well, I think I think what we've seen from Pam Bondi as Florida attorney general is she's going to be in that general mold.
