And, I've been covering the Second Amendment since, 2016 was the first time I started to really, look at writing from a journalism standpoint.

I've been writing for over 25 years. And in 2020 is when things really, you know, took off for me. And I started to really focus on, on this. And, for the last, you know, five plus years have been just hammering down and, you know, I put most of my work out at bearing arms. And then, as you mentioned, shooting news weekly, and I've had stuff and, you know, a bunch of other publications as well.

So it's.

It's kind of awesome. And you, you recently. Yeah. Yeah. So you recently wrote, a piece at Bearing Arms that looked at the NRA's election, the board elections. And, you know, this is something where I've, talked about a lot on the show and and at the reload, of the NRA now is through its New York civil trial.

And there they're done with that. And the key now is where they go from from there. And one of the big things to watch for is that talked about was this election, because you had I was at a board meeting that, one goes, a couple board meetings go and did the reformer group or whatever you want to call it, they call themselves NRA 2.0.

Had a majority on the board, this 76 person board, but they didn't have enough of a majority, a large enough majority to actually, implement the reforms that they wanted to do at that meeting. And they ran into some significant resistance from, other board members. A lot of former up here, associates, defenders, people who, you know, are still, in his corner, so to speak.

And, so this election, I think, was going to be key to see which direction the NRA might go if they were going to go further into the reformer realm, or they were going to, you know, keep the status quo more or less. And, so what what actually happened? You wrote a great piece that detailed how the results turned out and, yeah, I this is not something that I was has kept covered very closely.

So that's why I wanted to have you on. And talk about it. What, what what occurred on the in this election.

So I think and this is something you and I talked about in the back end. And, what's really interesting about the NRA board election and in particular as of late, is people are paying attention to it, as in people who are interested. Now, I think there's a couple elephants in the room that cannot be ignored. You know, the NRA has lost membership.

They've admitted that they've lost membership. The last number that I got on members from an official right, that was able to comment on it was in February. So February, I had, I had, interviewed Doug Hamlin, and Hamlin said that their numbers were just under 4 million. Now, he didn't give me an official number. And then there's also other unsubstantiated rumors that, you know, there's membership numbers are still dropping, but I haven't confirmed any of that.

So the only thing that I have to work off of is what he said. So there is a drop in membership, which is definitely an issue. And then of the members that the NRA has, we have to take into consideration.

Real quick on the membership numbers. By the way, Doug Hamlin, for anyone who doesn't know, is is the current executive vice president of the NRA. He took over after Wayne Lapierre resigned. But, so obviously a pretty good source. They're on to how many, members they have. But, at the same time, Bob Barr, who's the president of the NRA, sent out a memo to board members, recently that claimed, they'd seen, significant drop in lifetime members and, you know, he gave a percentage drop.

So, you could kind of calculate the number of lifetime members that were left from that. And then the NRA and this kind of speculation that you're getting it right.

I actually a blog that's followed this, they said that, if you one of the other ways to kind of estimate how many NRA members there are is through the, the subscriptions and their magazines, because every membership comes with a subscription to the magazine. And so, you know, if you put those two numbers together that are in danger, at least estimated there, there are somewhere around 3 million members.

So. Well, it's we got somewhere between 3 and 4, I think is fair to say. Yeah.

And and again, you know, I had read about the, the Bob Barr memo. I hadn't dug into it. I hadn't gotten an official position from anyone on it. So I'm not saying I'm discredited. I didn't discredit I mean, he's the president of the NRA, which I think is important to work like. So into the weeds on this.

It's important for people to understand how the structure works. So we talked about Doug Hamlin being the CEO and executive vice president of the NRA. And that's, somebody that works for the NRA. It's a paid position. And he serves at the pleasure of the NRA body. So the NRA board is the ones that hire and elect the executive vice president.

Previous to this, there was changes that were made previously. Members actually would vote on that as well. So you have hired, you know, employees, which is where Doug Hamlin would be. And then you have board members and officers, which is over here. Now the board members in the office are. So Bob Barr is a board member who was elected to be an officer of the board.

So he is now the president of the NRA. So that is not a paid position. These guys don't get paid. NRA board members don't get paid. NRA employees do get paid. So you are right there. You have a board that's supposed to regulate how the employees work. And then the employees are also supposed to be able to go to the board and say, hey, these are things that we need that we might not be able to have.

So just so people understand what's going on. So hearing this from Bob Barr isn't nothing. It's something he's the president of the board of the NRA. But we also haven't gotten anything substantiated from the employees of the NRA. And I don't know the process over on the, you know, information like, where did Bob get his information? I don't know, I didn't ask him.

So, you know, bottom line, I think for this, what really matters beyond just the state of the NRA and obviously they get their money from dues payments from these members.

That's where most of their revenue comes from. So it matters for that reason, too, and also for their political, power, because they represent the right people. The more people they represent, the more power they have. But it also matters to the elections because, one not all these people get to vote in the election. Not even not all members vote in the election.

So not not all members are eligible to vote in the elections. And so, it's only life members and those with five, you're in a know have five year memberships, right.

It has to be the full five consecutive years. You can't just get a five year membership. Right. You're good to go. You could get a lifetime membership, and you're supposed to go, so there's a lot of new.

So it's really limited the pool. Yeah, but it's really limited the pool of who can vote in these elections. And maybe that's you kind of mentioned earlier that like these elections, these board elections, you know, and in my experience, they weren't really very much like elections in the past, in the sense that, like, a lot of people got elected because they had been on the board for a while.

They're known quantities, they know names they have. The more you had a lot of celebrities on the board, and you didn't really see them running, like your traditional kind of political campaign to get on the board. Until this corruption scandal happened and now you've had a lot more of people running on actual platforms and what they want to do for the NRA.

And and you've had two different groups come up. You covered this in your piece, the NRA 2.0 or the reformers and the, strong NRA or the more, oh, old guard, I don't know why you how you.

And the biggest takeaway that really shook me was if you were not affiliated with either strong NRA, which is the we'll call it Old Guard or NRA 2.0, which we're referring colloquially to as the reformers.

You didn't get elected or reelected, only people who were affiliated with them, for lack of a better term, a party. And I don't know how else to describe it, a camp, maybe. So it's become somewhat of a politicized thing. And so if you didn't if you didn't have an affiliation, you weren't getting elected or reelected. And looking at, you know, some of the results here.

And I don't know if the results that I got from American Rifleman, if they were ranked as in the number of votes, but if they were the only unaffiliated person that came up close would be Jean Roche. Underneath the strong NRA candidate that didn't get elected. So these were all people that are now eligible for the 76 director.

But of the candidates that that were running, I want to say pretty much we can say NRA 2.0 kind of swept the election. And I've got the hard numbers here. I'll look at them. So there were 16 old guard or strong NRA candidates and ten of them won right. Either were elected or reelected. Then there were 28 NRA 2.0 candidates and 19 won.

So if you look at the percentages, 66% of the ballot was taken by NRA 2.0 and 34% was taken by strong NRA. So there's a clear decisive amount of, you know, power and and faith being put into what we're calling NRA 2.0 now. And I and I think that that's something that is, is good in the sense of people are paying attention.

But now they're engaged. You know, it looks like people are getting more engaged now. If there were some upsets or I'd say things that were shocks that were shocking, you and I kind of talked about we were shocked, you know, longtime board member Tom King, who is the president, I believe, a New York State Rifle Pistol Association, which is nice surp

Yeah. For the Bruin case, Tom King did not reelected and he's like a long term, long time board member for a lot of years. And,

It that's actually very fascinating to me because Tom King, not only was the is the head of the the state group that won Bruin, you know, the major Second Amendment, landmark case, the Supreme Court, but also he's been on the board for a very long time. And he's a very vocal board member. And I kind of wonder if that's why he didn't get reelected because of the he's vocal in defending Wayne Lapierre through all of this. Well, he.

Get up and defend Lapierre at like the members meetings and very, very harsh terms towards his critics.

So I spoke to Mr. King in January, and he's like, well, when I found out about everything. And then, you know, that all came out in the court case. I said, okay, so that came out in the court case.

And then then he testified, but he hadn't said anything that I could see, contrary to, to Wayne up until then. And so, you know, he spoke about that too. But I think some of the other things that also were flags on the play were and I talked to Mr. King about this as well, were comments that were made in a chat thread.

And you and I kind of talked about this when there was, a Facebook group that was opened up there that was a pro, for lack of a better term of pro reform. It's not these reformers, but it was just another group on social media, a private group of people that are coming together that want to discuss NRA issues from the vantage point of, you know, they're not happy with Wayne or, you know, how things are going under Wayne's leadership.

And Willis Lee, who is a board member now, he was reelected, I believe he was running as a reform candidate, as an NRA to point out. And that's a whole nother issue and a whole different story. What went down, what Willis Lee, and there's a whole lot there that I don't know what happened years ago because he was on track to be the president of NRA and got outed, oh, by the board.

So I don't know the details of that, but yeah.

And Tom King made some interesting comments there about neutralizing the people who were involved in that.

And I asked him about that, and he didn't really give me a very good answer, in my opinion. And that coverage is over at bearing arms and that shooting newsweekly. But the thing about the, the upset and I don't know, I don't know, upset is the right word because I don't have a horse in the race per se.

Is it was interesting that he did not get reelected. And then his public commentary about his not election. He made a public commentary on social media. So I don't feel bad about reporting. All this is saying, you know, there's a whole group of, bloggers and podcasters who are just spreading lies and, you know, defaming, you know, the NRA and for lack of a better term, the old guard.

And that's fine and dandy. But, you know, I'm a show me the money kind of guy. Like, if there was all of this defamation and all these lies or whatever were being said, call them out. Yeah. And look, it's, that's that's the kind of rhetoric that you've seen from from, many of the law piers associates and defenders on the board, for years now. And, you know, it's just given the breakdown that you you gave us there on the, you know, the what the at least in this election.

Look, not every board member is up every year, so this isn't they're only up every three years. They serve three year terms. So it's only one third of the board that's been refreshed here. So it's not as though it's going to be a 60%, NRA 2.0 board. But, you know, seeing them do very well and even very prominent members of the, the old, old guard, strong and array, I guess party, like you said, it's it's weird is weird to see them kind of divide into parties on the board now, but, that's certainly a very new thing.

But, you know, it's to see that it's very emblematic of what I think NRA members seem to want, which is significant change, because that's what the 2.0 people are promising. Right?

And I know they had to cut back on their staff tremendously in the past when they were having, more acute financial issues and, going back again to talking to Doug Hamlin in February.

He I think they are slated to hire 20 more employees to try to help. And I don't know in what exact capacity or whatever, but 20 more employees to the NRA, which is a good sign because it's showing that, hey, they're seeing some of that liquidity that maybe, hey, we can afford to have 20 more staffers. And then, of course, the assumption is they're going to be helping to advance forward and progress.

And I think it's also important to recognize that Hamlin was elected basically as kind of a more pro reform candidate, you know, when when he was tapped to do this and what's really great about Mr. Hamlin is, you know, his background is in journalism and in publishing. So he's got, a very different view of things. And, what I also like about him is he's put himself very forward and out there.

NRA, you know, club, they're having an event on, April 19th. So that event, he's scheduled to be at that event to participate there. And, you know, at that event, there's also going to be Adam Trout from Second Amendment Foundation Camp Edwards, who's a fellow board member on the Citizens Committee, and, you know, an editor of Bearing Arms.

So what I'm seeing is there's been a more push for the leadership to be public. And I think this ties into, of course, the successes that the board's going to have now. But, you know, it's it's they are faced with, serious challenges. You know, it appears from the election results that you outlined there that the reformers are going to have a more substantial control over the future of the NRA, and that they'll be able to perhaps pursue a number of these reforms that they want. And the you know, the question I think that's left is whether that's going to be enough or whether that's going to happen fast enough to pull them out of this tailspin that they're in because, you know, they're facing new challenges.

You know, they just finished the New York civil trial is now at an end. You know, there's some there were some reforms that were implemented as part of that, both by the NRA and by the court. So they have perhaps more unity and moving forward, more, ability to enact some stuff they want to do that they're hoping will convince people to come back. That's a pretty big blow to them politically, I think. And then also, they face several more legal threats. So Oliver North, the former president, who was pushed out by Wayne Lapierre when they when this corruption scandal first broke into public view, he's suing them again. And then David Della Koya is has just had some success in his class action lawsuit.

This is, a former NRA donor who's filed a class action suit, on behalf of other NRA donors who feel they were misled about their donations because they went to at least some part of them, went to paying what appears personal expenses rather than to the, the ends of the especially the NRA Foundation. He just got a ruling from a federal judge that said his suit can move forward on all claims, including even Rico claims.

So that's a pretty, pretty significant challenge they're going to have to face here. And so I guess the question is, right, whether they can actually convince people to come back fast enough to stop the, the bleeding, first of all, and then to, move things back in a positive direction for the organization where it can become, you know, more, like recapture some of the power and that it had, you know, before all this happened.

What's your thoughts on that?

Like, at the end of the day, this is a membership thing, a membership numbers thing. It's a donors thing. So if they can't pull in the money, obviously they're not going to be solvent.
